The soliciting materials distributed to stockholders contained the Amended Form of Proxy Card.

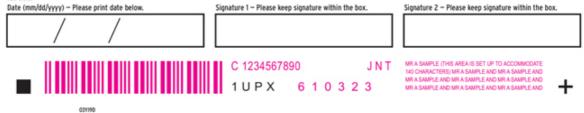
